1. Sprint SCC Microsoft Lync – Multi-Tenant and Workplace-as-a-Service – Rest of World (“ROW”) Outbound Off-Net Voice Pricing

ROW long distance calls are billed in 6-second increments with a per call minimum of 30 seconds. The exception is Mexico, which bills in 60 second increments.
