

SPRINT GLOBAL SIP TRUNKING INTERNATIONAL VOICE PRICING (Canada and Europe Origination)

- International long distance calls are billed in 6-second increments with a per call minimum of 30 seconds. Mexico, Global Mobile, Inmarsat SNAC, International Networks and UPTS termination is billed in 60 second increments.
- Where applicable, International Mobile Termination Surcharges must be included when pricing international voice.
- The International Mobile Termination Surcharge applies to certain international calls. The surcharge will apply to calls terminating to a foreign mobile or like service or to a routing code established for mobile or like services. The charge is a flat, non-distance, non-time-of-day sensitive rate which varies by country.
- This surcharge will be applied in addition to a customer's international plan or international discounted rate, in the same increment as the customer's plan or international discounted rate.
